## Instruction to Bidders

## Please read carefully!

- 1. You may inspect the items for sale at any time during normal working hours by appointment only. If the equipment is shown be appointment only, contact Ashley R. Locklear, Executive Director, at (910) 521-9711 to schedule an appointment.
- 2. If after viewing the equipment you are interested in submitting a bid, you must do so on the enclosed Bid Form. The Bid Form must be completed and signed by the interested purchaser and submitted on or before the deadline of November 18, 2024, at 12:00 pm. Late bids will not be considered.
- 3. You must include with your Bid Form a deposit equal to five (5%) percent of any bid in excess of one hundred (\$100) dollars. For example, a bid of \$5,000.00 should be accompanied with a deposit of \$250.00. We will accept CASH or CERTIFIED CHECK. The check must be made payable to the Pembroke Housing Authority. UNDER NO CIRCUMSTANCES WILL A BID BE ACCEPTED THAT DOES NOT COMPLY WITH THIS REQUIREMENT.
- 4. If you are the successful bidder, you will be notified by telephone the next business day (November 26, 2024) prior to 10:00 am. At that time, you will have thirty (30) days to pay the remaining balance owed for the purchase of the equipment (bid amount less the five percent deposit). If you do not claim the property before this deadline expires, your bid deposit will be forfeited and your right to purchase the equipment waived.
- 5. If you are not the successful bidder, your deposit will be returned to you at the address on the Bid Form. All bid deposits will be returned after the final sale of the equipment but no later than thirty (30) days from the date of opening.
